Aims and Objectives:

- To be able to identify, assess and refer cases that they consider are Safeguarding and to meet their statutory requirements for looked after children, adults and the mentally incapacitated
- To feel confident to apply the MCA in practice and Risk Assessment Child's Voice
- To understand the need for history taking and physical examination appropriate for safeguarding/child protection and legal processes.
- To understand the need for documentation, reviews and information sharing and appropriate analysis of risk
- To review how to identify possible signs of sexual, physical, or emotional abuse or neglect and what constitutes child maltreatment including the effects of carer/parental behaviour on children and young people.
- To be able to know how to work within the Early Help processes of CAF, TAC.
- To be able to know how to communicate effectively with children and young people, and to know how to ensure that they have the opportunity to participate in decisions affecting them as appropriate to their age and ability.
- ♦ To be able to know how to contribute to/formulate and communicate effective management plans for children and young people who have been maltreated or exploited
- ◆ To be able to understand and contribute to the processes of: Section 47 enquiries, Initial Child Protection Conferences and the Core Group
- Awareness of potential types of adult abuse and how they might be recognised, including; physical, emotional, sexual, psychological, financial, material abuse, discrimination, and negligence, domestic abuse, honour based violence, human trafficking and modern slavery, organisational abuse, cohesive control, Female Genital Mutilation (FGM), internet grooming and bullying
- The role of the Local Authority in the safeguarding adults, to include how to contact them with concerns.
- ◆ To have an understanding of the Mental Capacity Act and the role of an independent advocate under the Care Act 2014.
